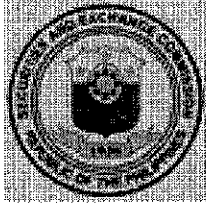

To preserve the remedies to which the Company as a taxpayer is entitled under relevant BIR Revenue Regulations, the Company has filed a petition for review with the Court of Tax Appeals questioning the validity of various tax assessments for the taxable year 1 July 2009 to 30 June 2010 and for the taxable period 1 July to 31 December 2010, on factual, due process and legal grounds. These assessments amounting to around PhP1.5B were the subject of a Final Decision on Disputed Assessment (FDDA).


